Dear Day Camp Parent(s),

Welcome to Day Camp!!! This letter should answer many of the questions or concerns you may have about this program. Our camp hours are from 7:30-6:00 each day. Every other week (typically Tuesdays or Thursdays) we will be bussed to various places in our community. These days, there will be an additional \$12 required to cover some the costs. **(These fees will only apply to campers who have signed up 4 days or less a week.)** Unannounced “Drop ins” may be turned away.

What to Bring: Campers will need to bring a bag lunch along with any snacks they may wish to have during the day. Kids will also need to bring along with them a swim suit, towel, a jacket or sweatshirt, water bottle, sun screen and bug spray. (We have limited spaces to keep personal items here at the YMCA.) **Please make sure that all of your children’s items are properly labeled.** If your child requires any sort of medication to be distributed please inform Day Camp Staff. All medications should be given to the YMCA staff in charge and must be accompanied with the proper medication permission form. We will make sure that these medicines are in a safe location and taken when needed.

Registration / Payment policies

All Campers must be registered (with appropriate fees paid) by the Thursday prior to the week attending. To make the registration process more convenient for you, we can now securely store your credit card and/or banking information in our new computer system. See the front desk to set up an account.

If you need to make adjustments to your schedule, we highly recommend having your banking information on file so that we may bill/credit your account as needed.

We realize that schedules change quickly and unexpectedly in the summer months. Please make sure you inform the Day Camp staff as soon as possible if a change is needed.

I am very proud of the people staffing Day Camp this year. You can be rest assured that your child will be in good hands. We will have life guards at the waterfront each day, and all lead counselors are First Aid and CPR certified.

This will be my 6th Summer Day Camp Experience and I am very excited to get to know you and your child this summer. WE WILL HAVE FUN!! Don’t hesitate to call me if you have further questions. Thank you for your support of Summer Adventure Day Camp 2010.

Sunscreen Policy

YMCA day camp participants spend a great deal of time in the outdoors and are thereby exposed to the sun's harmful rays. Since it is our commitment to promote healthy spirits, minds, and bodies, we follow the following policies in this regard.

- All campers and staff will wear sunscreen with and SPF of at least 15 on all exposed skin, including lips, daily, even on cloudy days.
- Parents or legal guardians will be responsible for applying the first layer of sunscreen prior to morning drop off.
- Parents or legal guardians will be responsible for providing their children with enough sunscreen (in a sealed container) to take with them for later day applications. One container per child, please.
- Day camp staff will be responsible for ensuring thorough follow-up applications after 1 hour in the water, after two hours of activity in the sun, (due to perspiration), and/or any other time as needed. **Please note, this will mean your child will have the sunscreen applied by day camp staff for them, or be instructed by the day camp staff to do so themselves. Please explain this to your child before camp.**
- For campers who have fair skin, freckles, or tend to burn easily and tan little or not at all; we recommend an extra t-shirt to be brought to wear in the water for extra protection.
- The YMCA reserves the right to disallow anyone to participate in the day camp program at any time for failure to comply with this policy.

Please note that these decisions were made to protect your child. Furthermore, our staff members have been trained on this subject and understand their responsibilities and the consequences for failure in observing this policy.

I hereby release and discharge the Brainerd Family YMCA, its agents, servants, and employees from any and all claims for injury, illness, death, loss, or damage which my child(ren) may suffer as a result of their participation in this program.
- I agree to comply with the YMCA day camp sunscreen policy.
- I understand that the Brainerd Family YMCA is not responsible for personal property lost or stolen while my child(ren) is/are participating in day camp.

I give permission for myself/my child(ren) to be photographed, videotaped, and/or filmed, while participating in YMCA activities, and for the resulting images to be used by the Brainerd Family YMCA for promotional purposes.

One goal of the Brainerd Family YMCA **Summer Adventure Day Camp**, is to provide kids with opportunities to try fun, outdoor activities. - requiring staff to be first aid and CPR certified,
- requiring kids to wear appropriate clothing and sunscreen,
- monitoring kids' sunscreen application and water consumption,
- traveling in small groups and using the buddy system while on fieldtrips.
