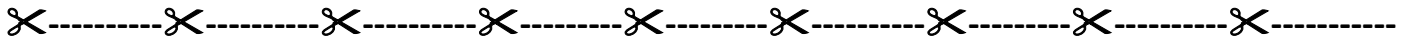

WAIVER & RELEASE FORM
